## **WORK IN PROGRESS**

---

### **Current research in progress:**

#### **1. Negligence in the School Setting**

This is a qualitative study I developed to meld research and enhanced student participation and learning.

Increased school negligence liability cases involving million dollar verdicts prompted in class assignments by our students to explore and understand extant negligence liability in the school setting and the role of the school administrator. I developed a "Tort Check List" and, after lecturing students and providing a series of readings, I have asked students to do field study in school buildings. The results and their papers have developed into this qualitative study of what is now a data set of 110 urban and suburban school buildings. The outcome of this study is enhanced student learning and a current research data set for publication which reflects issues related to school administration and negligence in the school setting.

#### **2. The Nature and Role of School Law in School Administrative Practice, A National Study**

This is a traditional quasi-experimental designed quantitative national study using the NCES list of over 17,000 school districts as the target population. The sample was stratified by judicial circuits and randomly chosen. The questionnaire was uniquely designed to enhance ease of completion and increase response rate. The data response has just been completed and data collection is underway. The first paper of what is anticipated to be a series of papers resulting from this new data set was presented at the most recent NCPEA national conference.

#### **3. War Stories from the Front**

This qualitative study focuses on how and to what extent school administrators make decisions on legal issues in school districts and school buildings. These are case study interviews with current and retired school administrators which are taped in our video tape lab. This study is just underway and 3 interviews/videos have been completed. It is the intent that each of these interviews be used as bases for a number of papers on leadership and decision-making on school law issues.

#### **4. Translating the Lessons of Brown to Today's School Leader: Using Historical Authenticity to Teach Relevancy**

**A study with use of and cooperation of the Library of Congress.**

A new generation of graduate students in our educational administration preparation programs reflect views of prospective school leaders who have not lived at the time of Brown. As we get historically farther from Brown, we have students who, through their comments and reflections in class, display limited understanding and, at times, denial, of the social, cultural and political ramifications of Brown and Brown II as they apply to school leadership today. The intent of this study is to identify authentic historic documents related to Brown and American's past for inclusion in publications related to the history of Brown, the implications of Brown

in current administrative practice and the preparation of educational administration programs on topics related to discriminatory practices in the school setting, inter alia, teacher hiring and firing, choosing of curricula, classifying students, grouping, programming and tracking of student groups. The historical courses can only be obtained through the varied collections of the Library of Congress. This study seeks to identify those documents through visits at the Library of Congress' varied collections and ultimately publish articles related to the implications of using historic original documents to understand and teach relevancy.

In accordance with this research study, I worked in coordination with the Library of Congress to present an interactive video conference to my Summer Cohort, 2005, students, on this very topic. Six prior months of e-mails and a meeting with the Library of Congress in Washington was required to accomplish this. The results were profound, as reflected in student comments and work. As a continued result, I will continue to seek opportunities and funding for visits and research at the Library of Congress to meet this study's goals.
