Center for Math and Science Education (CSME)

Karin Lange Receives NCTM Award

Karin Lange, Assistant Director of Math Programs in CSME, along with co-authors Dr. Kelly McGinn and Dr. Julie Booth, both from Temple University, were awarded the *Linking Research and Practice Outstanding Publication Award for 2016-2017*, by the National Council of Teachers of Mathematics (NCTM). They were recognized for their article "A Worked Example for Creating Worked Examples," published in the August 2015 edition of Mathematics Teaching in the Middle School. This award was given as part of NCTM's commitment to increase the connections between research and practice in mathematics education.

Karin also presented at the NCTM Research Conference in San Antonio, TX this past spring, with a presentation entitled *Urgency in Math Classrooms: Research Partnerships for Instructional Change.*

Public Choice Award for CSME Video

CSME presented its video, *Cultivating Whole School Implementation of the Next Generation Science Standards*, during the 2017 STEM For All Video Showcase funded by the National Science Foundation. The theme of this year's conference was "Research and Design for Impact" and included 150 videos from across the country in a forum that allowed researchers, practitioners, administrators and policy makers to interact online from May 15-22, 2017. **Rachel Shefner** and **Stacy Wenzel** responded to comments posted about the video during the entire week. The video received *Public Choice* recognition by obtaining a large number of votes from people who viewed the video.

Linda Brazdil Recognized with Faculty Partner Award

CSME Director **Linda Brazdil** has been honored as a faculty member who has supported Student Academic Services and its retention and enrichment programs outside the classroom.

NSF Noyce Scholar Grant to SOE, collaborators in CSME

A prestigious National Science Foundation (NSF) Robert Noyce Scholar Program grant has been awarded in the amount 1.2 million dollars to fund a collaboration to better prepare Chicago Public School (CPS) math and science teachers. PI Lara Smetana of the School of Education will work with co-PIs Jim Breunlin, Peter Tingley, Linda Brazdil and Karen Lange on the training of math and science teacher candidates who will later teach in high-needs CPS schools.

Senn High School Partnership

Approximately 250 neighborhood freshmen and sophomores at Senn High School completed the Loyola STEM Challenge to propose ways to reduce energy consumption or produce energy more sustainably for their school. This project served as part of their Design Course, a STEM course created in collaboration with CSME faculty. Twenty-two undergraduates from Loyola served as online mentors for the students during this challenge. On April 27, the top team presented their project, proposing windmills on the roof at Senn High School, at the Illinois Science and Technology Institute's STEM Challenge Student Showcase at Motorola Mobility in Merchandise Mart.

This project was carried out as part of Loyola's "Plan 2020: Building a More Just, Humane, and Sustainable World", specifically working to expand and deepen the partnerships with PK-12 schools in Rogers Park and Edgewater.

Loyola Math and Science Connections Project

CSME received a grant from the Illinois State Board of Education (ISBE) to partner with Chicago Public School's (CPS) Network 8 and the CPS Department of STEM to host professional learning communities to build K-8 teachers' knowledge of math (Common Core State Standards) and science (Next Generation Science Standards) standards; implementation practices that make connections between math and science; use of formative assessment to guide student learning; and leadership skills. Thirty-three teachers from eight schools attended the kickoff event on June 26. These teachers will also participate in two book studies, attend a 2-week summer institute, and attend professional activities throughout the 2017-2018 school year.

Advanced Placement Summer Institute

July 10-14 will bring approximately 172 teachers to campus for our Advanced Placement Summer Institute (APSI). Workshops in biology, calculus AB, calculus BC, chemistry, environmental science (at LUREC), physics 1, physics C, statistics, computer science principles, economics, and human geography are being offered. These workshops are endorsed by the Midwest Regional Office of the College Board, led by College Board-certified AP consultants, and provide participants with the experiences necessary to successfully teach an advanced placement course in their discipline.

Students Work With CHRC on Children's Rights

Gannon Center Announces Faculty Fellows for the 2017-2018 Academic Year

The Gannon Center has awarded two Faculty Fellowships for the 2017-2018 academic year. **Noni Gaylord-Harden**, **PhD**, Associate Professor of Psychology, and **Patricia M. Sheean**, **PhD**, RD, Assistant Professor of Nursing, will be advancing original research in their particular fields. Each will be focused on her research proposal during the spring of 2018 and the Gannon Center will reimburse her department with the cost of her teaching replacement. Dr. Gaylord-Harden's proposal, "Understanding reactivity to community violence exposure in African American adolescent females from low income, urban communities in Chicago" focuses on desensitization as one of the most dangerous consequences of high levels of exposure to violence. Gannon Center Announces Five New Johnson Scholars for 2018-2020

The Gannon Center has awarded five rising juniors with the Johnson Research Scholarship for their junior and senior years. Each will be awarded a \$4000 scholarship with a \$1500 research grant each year.

Colette Copic will be working with faculty mentor, **Dr. Amy Krings**, from the School of Social Work, on researching the "Effective mobilization and allyship in environmental community organizing: Case study of Pilsen, Chicago."

Grace Koch, a theatre and political science major, will be investigating theatrical interventions to address the rancor that accompanies political discussions across the conservative-liberal spectrum.

Olivia LaRocco will be working with **Dr. Ruth Gomberg-Munoz**, from the Anthropology Department, will be exploring the impact of mass job loss on crime rates, health, family, education, and finding employment in a post-manufacturing economy.

Margaret Schroer will research the effects of yoga on college students with depression and anxiety. Working with **Dr. Rebecca Silton** in the Well-being and Emotion Laboratory inspired Maggie to pursue this inter-disciplinary project.

Michelle Sharpe, an education major, will be working with School of Social Work mentors, **Dr. Maria Vidal De Haymes and Dr. Amy Krings**, on evaluating the Parent Mentor Programs for its effectiveness in supporting parents improve the academic outcomes of their children and promoting parents as agents of engagement, integration and investment between immigrant families, schools and communities.

NIH Abandons Plan to Limit Per-Person Grant Awards

Facing protests from senior scientists, including members of its own advisory board, the National Institutes of Health on Thursday abandoned a plan to help younger researchers by imposing a general three-grant limit.

Instead, the NIH is moving forward with a more complicated formula in which scientists who win a first grant under a program designed to aid first-time applicants will get priority for their second grant.

The agency says it is shifting to a new strategy but not from its goal of helping younger scientists compete for NIH support.

"We are shifting the approach quite substantially," the NIH's director, Francis S. Collins, told a gathering of his advisory panel, a collection of about 15 senior academic researchers that largely opposed his first plan.

The new plan will still boost younger scientists, Dr. Collins and other NIH officials emphasized. But the three-grant limit was scuttled largely because NIH experts no longer felt confident in the data analysis they used to develop it.

Dr. Collins told Congress last month that he wanted the planned limit — scientists would be allowed to hold no more than the equivalent of three full-size NIH grants at any one time — because of internal NIH data showing three grants to be the point where researcher productivity as measured by journal citations tends to decline.

But, Dr. Collins told the advisory panel Thursday, outside analyses raised doubts about that conclusion. In addition, he said, NIH officials heard questions about how exactly to measure a three-grant equivalency in situations such as team projects. And, he said, critics questioned whether such a "formula-driven approach" fit with the NIH's longstanding commitment to merit-based grant awards.

The NIH's deputy director, Lawrence A. Tabak, who played a central role in <u>drafting the new plan</u>, described his fear that researchers who manage to win an initial NIH grant face a fundamental disadvantage because they usually lack the internal institutional resources that a senior faculty member can tap to keep his lab alive in the event of a subsequent grant rejection. "They have more resiliency," Dr. Tabak said of older scientists. "They're able to stay in the game long enough."
