Biographic History

Marion Jean Kennedy was born on November 27, 1934, the daughter of Marion Mitchell and Edward Kennedy. Growing up on the south side of Chicago, she attended Maria High School, but came to the north side of the city to attend and graduate from Mundelein College. She married Camillo Volini, and they raised their five children in the Lakewood-Balmoral neighborhood of Chicago. Until she entered politics, she was a teacher and speech therapist in the Chicago Public Schools.

Marion Kennedy Volini was formally inducted into her office as Alderman of Chicago's 48th Ward on July 7, 1978. That comparatively short ritual in the City Council chambers gave no indication of the years of groundwork, which singularly adapted her for political office. Ten years earlier she had collaborated in the formation of a neighborhood organization - the Lakewood Balmoral Residents Council - to upgrade what at that time was known as a deteriorated area, characterized by a transient population, many unskilled or unemployed, housing shortages, negligent property owners, and store closings. This area included Edgewater and Uptown, which had become a refuge for many unlicensed alcoholic treatment centers as well half-way houses for state-released mental patients.

Her first venture into city politics presented itself when 48th Ward Alderman Marilou Hedlund announced that she would not run for re-election. Marion Volini - the wife of lawyer Camillo, the mother of five -with no money, no experience, and no campaign organization - ran against Arnold Levy and Dennis Block - and lost!! However she had won recognition as a community leader. She

was asked to run for President of the Edgewater Community Council - which she won in an uncontested election.

When Alderman Dennis Block resigned after two years, a Special Election was announced with a primary and a run-off. Again Volini was on the ballot as an Independent who had the support of both the Democratic and Republican organizations. This campaign became a family affair - with Volini family members, large and small, participating in precinct work - making calls, stuffing envelopes. And when the votes were tallied on election night, Marion Volini was the new Alderman of the 48th Ward - to finish the unexpired term of the former Alderman.

The 48th Ward, with its 59 precincts, has a population of 60, 000, and extends from Lake Michigan west to Clark St. and from 4700 North to 6200 North. Citing personal and informal demographics, Alderman Volini described the diversity of her area: "My community, on the very far north side lakefront, consists of the very rich and the very poor, the very old and the very young. We have families with children, and we have young couples and singles. The residents of my community are black, white, Hispanic, and Asian-American, and compose one of the few stable integrated communities in Chicago...The housing in the 48th ward includes high-rise condominiums, elegant Victorian homes, and beautiful re-habbed walk-up apartments. But we also have large common-corridor buildings, subsidized high-rise structures, and a number of deteriorated vacant buildings.

Her appreciation of the 48th Ward's ethnic cultural mix she described from another perspective: "a real richness of our community is the many-ness of our people. Six p.m. mixes the combined cooking aromas of the Far East - of Bangkok - and the haciendas of Mexico. Dining out here includes a choice of restaurants offering home-made specialties like shrimp tempura, Swedish meatballs, Mexican enchiladas, Peruvian pastry, gyros on pita bread, and some of the best deep-dish pizza anywhere."

Immediate problems confronted Volini. The 48th Ward included the Uptown and Edgewater areas - scenes of many unsafe abandoned buildings, dirty streets, and high crime rates including arson, muggings, drugs, and rape. As Alderman, with her seat on the City Council, she was empowered to focus on improving neighborhood safety, housing rehabilitation, commercial revitalization, traffic congestion, as well as the prevention of lakefront erosion. She sponsored legislation concerning playground safety and prostitution. As Chairperson of the City Council's Committee on Aging and Disabled, her efforts worked toward improving services and accessibility for senior citizens and the physically handicapped.

During her three terms as Alderman (1978-1987), Volini served under two first's for Chicago mayors - Jane Byrne, the first woman mayor, and Harold Washington, the first African American mayor. In a confrontation during an April City Council meeting, Mayor Washington adjourned the session, but his opponent Alderman Edward Vrdolyak continued the meeting after Washington and his supporters left the chambers. Volini was the only one of Washington's supporters to remain.

The next day Volini presented a compromise proposal for City Council Committee chairmanships to the Mayor - and later faced down the Vrdolyak 29 - authorizing herself a negotiator. Later the Mayor appointed Volini as the only woman on the Washington six-member negotiating team. Her

warning to the City Council was quoted in Time Magazine (May 23): “This is chaos. The sooner we get it under control, the better.” For more than four weeks city government was in a stalemate. Only after four meetings did both sides of the negotiating team reach consensus. It was from this chaos that Volini emerged in a position of Council leadership. Later she said that her motivation in assuming a leading role in this City Council dispute was her belief that power should be distributed equally - that no one should be excluded from the governmental process because of race or political ideology.

At the conclusion of her third term as Alderman, Volini opened her own real estate company, Lakefront Group. She continued to serve the City as a mayoral appointee to the Metropolitan Pier and Exposition Authority, which has under its jurisdiction Navy Pier and McCormick Place. Her home is still in the Lakewood-Balmoral neighborhood.

Scope and Content

Marion Kennedy Volini’s papers pertaining primarily to her tenure as Alderman of the 48th Ward have been divided into fourteen series with multiple subseries and subcategories denoted by either bold or italics.

Series 1: Election Materials, 1975-1987, n.d. Boxes 1-7

These records contain election materials. Primarily they are the records of Marion Volini’s election campaigns. However, there are materials that pertain to the election campaigns of other candidates. The series has been separated into five subseries.

Subseries 1A: Campaign Scrapbooks, 1975-1986, Box 1.

Materials include two Scrapbooks of campaigns – one bound scrapbook, 1975 –86; one book enclosed in folder to which is added memorabilia, 1975

Subseries 1B: 1975 Election (Lost) and Special Election, June 6, 1978, Box 2.

Materials include statements of candidacy and audiocassettes of the Volini City Council Inauguration.

Subseries 1C: Election Coverage - 1979 – 1983, Boxes 3 - 5

Materials reflect Volini’s participation in alderman election campaigns. Materials include voter registration materials, ward canvassing, volunteer campaign workers, Election Day tallies and results.

Subseries 1D: Fundraising Events, 1979 – 1987, Box 6.

The contents of this subseries cover the separate events used for campaign fundraising as well as advertising and campaign expenses.

Subseries 1E: Other Political Candidates.1975 – 1987, n.d., Box 7.

This subseries includes campaign and election materials from other political candidates in the Chicago area. There are multiple entries for Mayor Harold Washington, Richard M. Daley, and Alderman Kathy Osterman, which comprise the bulk of this subseries. Additional material for local politicians is also included.

Series 2: Framed Certificates, 1978, Box 8

This subseries contains framed certificates of Volini's swearing in and oath of office.

Series 3: Chicago City Council Government Materials, 1961 – 1987, Boxes 9 & 10

This subseries contains Chicago City Council government materials. Materials include Rules of Order, resolutions, ordinances, various amendments, municipal code, meeting materials, correspondence, committee lists, mayoral appointments, and complaints/suits against the city government are followed by Comptroller's annual reports, 1977, 1979, and 1981-1985.

Series 4: City Council Committee Work and 48th Ward Issues, 1965 – 1988, n.d., Boxes 11-24

The material in this subseries primarily reflects the work of Chicago City Council Committees with regard to certain issues as they apply to the 48th Ward. It has been separated into 12 sections. Marion Volini was a member of many of these committees during her tenure as Alderman, although there are sections reflecting her involvement in an issue unrelated to her committee membership.

Subseries 4A: Aging and Disabled, 1965 –1987, Boxes 11-15

This section has been divided into seven parts: Committee on Aging and Disabled, 1981 to 1987, Department of Aging and Disabled, 1984 to 1987, Rehabilitation Act of 1973: Section 504, 1979 to 1987, Disabled and elderly issues and programs, 1965 to 1987, Organizations on the aging and disabled, 1984 to 1986, Chicago departments and offices, 1984-1987, Publications on the aging and disabled, 1977 to 1986.

Subseries 4B: Committee on Beautification and Recreation, 1984 –1987, n.d., Box 16

This series focuses on the gentrification and upgrading of public lands located in the 48th ward. – playgrounds, beaches - as well as development materials for the North Lakeside Cultural Center and the Viatorian property. Of primary interest in these files is the Playground legislation, *i.e.* safety mechanisms on recreational devices - in the form of ordinances, amendments, and documents. Also included are relevant correspondence and newsclips.

Subseries 4C: Community Development, 1979 – 1986, Box 17

In this series attention is directed to specific neighborhood locations and institutions with plans for their improvement – Edgewater, the Broadway Armory, Argyle St. The inclusion of the Chicago Tribune Magazine, featuring the Asian community on Argyle Street, is of particular interest highlighting as it does the individual ethnicity of this section of the 48th Ward. Agendas, minutes, correspondence and related materials are included.

Subseries 4D: Finance Committee, 1983 - 1986, n.d., Box 18

Much coverage is given to the Minutes of the City Council's Subcommittee on Finance of which Alderman Volini was the chair during this period. City Budget reports, Finance Committee Ordinances and Resolutions, Documents, Notes and Newsclips on Finances and Taxation. Related papers complete the materials found in this section.

Subseries 4E: Housing, 1979 – 1988, n.d., Boxes 19 and 20

Included in this section are Department of Housing Ordinances, meeting notes, agendas, resolutions, newsclips and housing publications as well as audiotapes of the Housing Court Subcommittee. Under the division "Shelters and Halfway Housing" will be found Landlord/Tenant Ordinances, Zoning Issues regarding Halfway Houses, Shelters in Edgewater, correspondence supporting a lodge for homeless women. Another division within this section centers on Condo development within the 48th Ward. Included in this section are the Chicago Ordinances relating to Condominiums, feedback from the Condominium Symposium, correspondence and newsclips pertaining to condominium issues.

Subseries 4F: Lakefront Erosion, 1976 – 1987, Box 21

The eastern boundary of the 48th Ward is Lake Michigan. Checking on the condition of their section of the shoreline is one of the Ward's responsibilities. In this section the problem of lakefront erosion is considered under a Shore Protection Study made by the Department of Transportation, an Appraisal Report by the Army Corps of Engineers, Ward Administrative materials, press statements, and newsclips.

Subseries 4G: Sister City with Sweden, 1976 – 1987, n.d., Box 21

The strong ethnic base of one section of the 48th Ward – Andersonville – prompted the setting up of a 'Sister' city in Sweden - *i.e.* Gothenburg. Documents pertaining to this relationship as well as to the formation of a Swedish-American Museum are included.

Subseries 4H: Garbage, 1983 - 1987, n.d., Box 21

The primary focus in this section is the problem of garbage. The City published Codes and Ordinances regarding Refuse. The Alderman's Office issued documents and notes pertaining to garbage - issues relating specifically to its disposal in condos and co-ops, summons for garbage violations with photos and newsclips.

Subseries 4I: Mental Health, 1972 – 1981, Box 22

Alderman Volini was a member of the After Care Task Force Committee. Edgewater-Uptown Community Council documents form the introduction to the problem of mental health. Opposition to the establishment and licensing of the Somerset Shelter House is covered by newsclips. De-institutionalization is considered in an article by Nancy Slagg. Volini's response was presented at the American Psychiatric Association Convention in 1981. Correspondence, policies and publications on Mental Health as well as the proposal for a Community Center provide additional information on this subject.

Subseries 4J: Prostitution, 1972 – 1986, n.d. Box 23

Prostitution in the 48th Ward was a major concern not only to the Alderman and her constituents. Its scope was city wide as is evidenced in Municipal ordinance legislation. Correspondence from the Chicago Crime Commission, relevant materials from organizations participating in the Interdisciplinary Committee, a report on legislation affecting Prostitution enforcement, ordinances and referendum regarding Prostitution Laws, a 48th ward street barricade against prostitution, TV editorials, press releases, newsclips comprise the contents of this entry.

Subseries 4K: 48th Ward Re-Mapping Project, 1985 – 1986., Box 24, File Folders 24-1 & 24-3 The 48th Ward engaged in a re-mapping project during 1985 – 86. This section contains an analysis of the plan, rulings resulting from remapping litigation, and ward re-districting.

Subseries 4L: Varied Council Materials, 1977 – 1987, Box 24, File Folders 24-4 & 24 – 16. Small material from different council committees arranged chronologically, 1977 – 1987. Materials include for example CTA issues, Fire and Police Commission, Liquor Licensing, Streets and Alley Commission, and Public Works Committee.

Series 5: 48th Ward Administrative Materials, 1962 – 1988, n.d., Boxes 25 & 26

Materials with particular reference to the Ward are included in this section. There are administrative materials that include copies of the newsletter "From the Alderman's Desk", press releases, 48th Ward Business and Service Directories, Service Contribution Awards, and MKV Daytimers. There are also a wide range of materials of 48th Ward subjects arranged chronologically in box 32 and include for example indictment materials against incumbent ward committeeman Martin Tuchow, an Aldermanic Questionnaire, Police Department Foot Patrol, parking issues, congratulatory letters to constituents, a satirical revue, and article about MKV.

Series 6: Activity and Materials of Community Groups and Organizations in the 48th Ward, 1962 – 1988, n.d., Box 27

Contents reflect activities of various neighborhood groups. They include for example Edgewater Community Council, Edgewater Community Coalition, Lakewood Balmoral Residents Council, Uptown Chicago Commission, and Andersonville Community Groups.

Series 7: Correspondence, 1978 – 1987, n.d., Boxes 28-32

(Note: Letters from 1984 and 1985 were not included in the archival deposit)

Included under this heading is correspondence with City Council Departments, recommendations/acknowledgements primarily with Constituents, letters from constituents, and a miscellaneous grouping.

Series 8: Speeches, 1970 – 1987, n.d., Box 33

Materials are grouped together by topic as well as recorded as individual events where it was possible. Materials include copy of text delivered, text with editorials comments, notes, and handwritten notes.

Series 9: News clippings, 1973 – 1980, n.d., Box 34

Collected by her ward office, these items have been separated by topic and arranged chronologically.

Series 10: Awards presented to Marion Volini, 1976 – 1989, n.d., Boxes 35-37

These materials include awards bestowed on Marion Volini. They include for example awards of appreciation, good neighbor awards, and Chicago City Council honors.

Series 11: Photographs 1979 – 1988, n.d., Boxes 38 and 39

In this collection, Alderman Volini is pictured with prominent Chicago political personages as well as at special 48th Ward events.

Series 12: Marion Kennedy Volini Tribute Dinner Materials, 1986 – 1987, Box 40

Materials include the announcement of not seeking re-election, the planning and executing of a tribute dinner, records of the activities at the dinner, and fundraising materials for scholarships in Volini's honor.

Series 13: Publications, 1983 – 1984, n.d., Boxes 41-44

This division contains printed material relating to such topics as City Council accountability, civic life, budgets, property taxes, ethnic communities, public services, homelessness, and landmarks as well as managing and negotiating.

Series 14: Non-Aldermanic Materials, 1956– 1993, n.d., Box 44

This varied material lies outside the administrative boundary of the Alderman's Office – but was part of the initial deposit of records. Of special interest are the files on Ed Marciniak, a prominent Chicago social activist and supporter of Alderman Marion Volini.
