Biographical Sketch

Mine Cinar has been involved in economics and business associations for many years. She received her B.A. at Robert College in Istanbul, Turkey, before receiving her M.A. from Vanderbilt University and her Ph.D. from Texas A&M University. Her research interests include global development finance, gender, statistics, and decision sciences.

Cinar has been a member of the Loyola University Chicago faculty since 1983 and participated in eight presentations on faculty publications from 1988 to 2011. She was a member of Loyola's Financial Committee, a committee of the Board of Trustees, from 1990 to 2000.

Cinar has published many works including *Topics in Middle East and North African Economies Vol. 7-15*, and has presented numerous papers such as "Augmented Tourism Demand for the Mediterranean", "Global versus Regional Interests: FDI in India", and "Comparative Banking Regimes in Jordan, Saudi Arabia and Egypt." Her professional and community affiliations include ex-officio positions for the Middle East Economic Association, editor for Topics in Middle Eastern and North African Economies and Electronic Proceedings Journal of MEEA, associate editor of the Review of Middle East Economics and Finance, Routledge Press, The Journal of Economic Asymmetries, and APF Press, and as an Economic Research Forum Fellow. Cinar has garnered several awards such as Quinlan Faculty of the year (2001, 2005) and Faculty Advisor of the Year-Economics Forum (2004). She currently teaches two economics courses at Loyola: Emerging Markets and the Multinational Firm and Game Theory and Strategy.
