## **Administrative History**

One of the first electrical shops in the city of Chicago opened in 1868. Owned and operated by George H. Bliss and L. O. Tillotson, this shop eventually became the Western Edison Light Company in 1882, with the rights to sell Edison electrical lights. In 1887 the Western Edison Light Company became the Chicago Edison Company and in 1892 Samuel Insull was elected as president of the company. Another electrical company, the Cosmopolitan Electric Company, incorporated in 1895 and in 1898 an operating contract was signed between the Chicago Edison Company and the Cosmopolitan Electric Company. These two companies consolidated into the Commonwealth Edison Company in 1907.

## **Scope and Content**

The Commonwealth Edison Company records compose 13.25 linear feet spanning the years 1893 to 1983, and include company histories, by-laws, agreements, leases, mortgages, and reports. The records are arranged by company.

#### Series

#### Series 1: Historical Records, 1904-1953, Undated. Boxes 1-3

The historical records series includes company histories, information about the Chicago Edison Company, statistics, and data gathered for a company history.

#### Series 2: Commonwealth Edison, 1893-1983, Undated. Boxes 4-10

The Commonwealth Edison records include annual reports, by-laws, the first agreement between the Chicago Edison Co. and the Commonwealth Electric Co., other agreements, and financial statements.

#### Series 3: Aurora, Elgin, and Fox River Electric Company, 1923-1924. Box 11

The Aurora, Elgin, and Fox River Electric Company records contain mortgages and deeds.

#### Series 4: Chicago & Illinois Midland Railway Company, 1936-1938. Box 11

The Chicago & Illinois Midland Railway Company records consist of annual reports.
