Administrative History

Samuel Insull commissioned Benjamin Marshall of Marshall and Fox to design a new residence on his land in Libertyville, IL, in 1914. Construction began towards the end of 1914, finishing in 1916, and was handled by the George A. Fuller Co. as the general contractor. Famed landscape architect Jens Jensen designed the gardens for Hawthorn Farm.

Scope and Content

The Hawthorn Farm construction records consist of 4.25 linear feet (not including blueprints) spanning the years 1914 to 1916 and include correspondence, samples, daily log books, subcontractor work logs, payroll books and time sheets, freight notices, general notes, blueprints, and subcontractor agreements. Arrangement is alphabetical.
