#### **Biographical Sketch**

Judge John C. Fitzgerald was born in 1903 in Boston, Massachusetts. He graduated from Boston College in 1925, where he was an honors student and All-American goalie for the college's hockey team. Fitzgerald later received his J.D. from Harvard Law School in 1928.

Fitzgerald began working at Loyola University Chicago's Law School as a faculty member in 1929, commencing a 30 year career at the school. In 1937 he was named the Dean of Loyola University Law School, and held this position until 1959. During this tenure, Dean Fitzgerald reshaped the law school's curriculum while revitalizing its student body following the school closure during World War II. Fitzgerald's curriculum valued research and legal theory, preparing graduates for work in all jurisdictions and practices. Fitzgerald's changes also stressed morality and public service as being important qualities for those pursuing a legal career.

In addition to his efforts at Loyola, on several occasions Fitzgerald served both the government of the United States and its legal community. During the Law School's closure for World War II, Fitzgerald worked with the government's Alien Enemy Hearing Board in assessing the status of "enemy threats" in America and their legal protections (1941-1942). Fitzgerald then worked with the Office of the Alien Property Custodian overseeing the legal status of personal property and redress of alien enemy detainees (1942-1946). Dean Fitzgerald also served the government through his work on the Atomic Energy Commission (1949-1957), where he evaluated access restrictions for those participating in the United States' atomic energy program. In addition, Fitzgerald

served the civilian sector through his work with the National College of State Trial Judges (1959-1970), and participated in the American Bar Association's performance reviews of law schools around the United States (1951-1961).

After leaving Loyola in 1959, Fitzgerald worked as a judge and administrator in the Circuit Court of Cook County, and was a leading figure behind the reorganization of the court system in 1964. Fitzgerald served over twenty years with the Cook County Circuit Court, with most of his efforts directed at finding solutions to the massive backlog of cases in Cook County and the inefficient organization of the court system. As an administrator of the court, Fitzgerald also participated in numerous National Conferences of Court Administrative Officials, where he provided direction and leadership. Fitzgerald retired from the courts in 1979 and moved to South Carolina where he spent the rest of his years. Fitzgerald remained closely tied to the Cook County Circuit Courts and Loyola University until his death in 1991.

## **Scope and Content**

The John C. Fitzgerald papers consist of 6.0 linear feet spanning the years 1942-1992. The collection is comprised of five series: Loyola Law School, Governmental Work, Academics Outside of Loyola, Cook County Circuit Court Reorganization, and Cook County Circuit Judge. The papers include personal and professional correspondence; notes; brochures; photographs; and reports. Subjects covered include the Cook County Circuit Court, Loyola University School of Law, the Atomic Energy Commission, and the Alien Enemy Hearing Board. Some notebooks and case files include notes written in Fitzgerald's version of shorthand.

#### **Series**

## Series 1: Loyola Law School, 1927-1992, N.D., Boxes 1-2

This series contains correspondence, brochures, notes and photographs pertaining to John C. Fitzgerald's tenure as Dean of the School of Law of Loyola University of Chicago (1937-1961). The series includes correspondence with university administration, particularly of note Father James Hussey, President of Loyola; correspondence with Adlai Stevenson, then Governor of Illinois, regarding Fitzgerald's appointment as a member of the Illinois Legislative Advisory Bureau (1950); and documents relating to events at Loyola, including the Loyola Convocation (1948), and the university's Diamond Jubilee (1984). Volumes in box 2 are in especially fragile condition and have been placed in phase boxes for protection.

## Series 2: Governmental Work, 1939-1957, N.D., Boxes 3-4

Included in this series are notes, correspondence, and reports related to Dean Fitzgerald's activities working for the federal government during two different periods. Particularly of note are Fitzgerald's notes and case files from his work with the Alien Enemy Hearing Board during World War II (1939-1942), as well as his work with the Atomic Energy Commission evaluating security clearance for potential employees (1942-1957). In addition, the series includes the draft of a banking code for the state of Illinois written by

Fitzgerald in 1939, as well as a copy of the bill passed by the state based on this draft (1939).

## Series 3: Academics Outside Loyola, 1951-1970, N.D., Box 5

This series contains correspondence, notes and reports related to Dean Fitzgerald's work with the American Bar Association's professional reviews of law schools (1951-1961), as well as his participation in the creation of the National College of State Trial Judges (now the National Judicial College), and as a faculty member and department chair (1959-1970). Also included are correspondence and notes from Dean Fitzgerald's work in an advisory capacity for the American Bar Association (1959-1961).

### Series 4: Cook County Circuit Court Reorganization, 1952-1981, N.D., Boxes 6-7

The Circuit Court Reorganization series includes personal notes, case files and correspondence related directly to Dean Fitzgerald's work in the Illinois Circuit Court System, with most materials covering his years working for Cook County. Of note are Dean Fitzgerald's notes and correspondence from his work in formulating the Judicial Article of 1964, which reorganized the Illinois court system, as well as his efforts in eliminating much of the court's burdensome backlog (1952-1973). Correspondence includes exchanges with Chicago Mayor Richard J. Daley and other prominent Illinois and national court administrators.

#### Series 5: Cook County Circuit Court Judge, 1964-1976, N.D., Boxes 8-10

This series contains booklets and notebooks used by Fitzgerald during the years he served as a judge in the Cook County Circuit Court (1966-1979). Booklets in the series deal primarily with legal theory and cases presided over by Fitzgerald, specifically the trial of suspected Skokie murder John V. Carter. The notebooks contain Fitzgerald's hand written trial notes for cases from 1964-1976.
