Corporate History

The following biographical and historical sketch is provided only as an overview to assist the users of this collection. Much of this information has been drawn from two essays written by Steve Waichler: "The First Fifty Years of Follett Corporation", and "Follett: Partners in Education, 1873-1996." The rest of the information has been drawn from other items in the collection itself, and from conversations with Follett staff and family members.

This biographical and historical sketch was written by Judith Robins.

C. M. Barnes Company, ca. 1873-1908

Charles Montgomery Barnes was born in Canton, Illinois, in 1833. He was the son of the Rev. Romulus Barnes, who had come to Illinois three years previously. Charles M. Barnes also chose the ministry as a career. Anecdotes state that an illness forced him to leave his profession, and that as a source of ready income he sold his own library. The year in which this occurred is variously given as 1872, 1873 and 1874. Mr. Barnes quickly developed a full-time business in the sale of used books. By 1876 he had moved both his home and his business from Wheaton, Illinois to Chicago. He changed his business premises frequently throughout the next twenty years. The business was incorporated as the C. M. Barnes Company on 17 February 1894.

Charles M. Barnes married Ellen Moore. Their son William Robbins Barnes was born in 1865. Records in this collection relating to the incorporation of the new company, as well as court records consulted by historian Steve Waichler, reveal that the company received infusions of cash from one J. H. Moore and one S. W. Moore. They, and several other members of the Moore family, were early stockholders of the company. It seems likely that these individuals were related to Mrs. Barnes.

In 1901, Charles W. Follett was hired on a temporary basis. He remained with the company, however, and quickly rose to a position of leadership. Eventually he was to become the owner and President of the company.

C. M. Barnes--Wilcox Company, 1908-1917

By the time the business was first incorporated in 1894, Charles' son William R. Barnes was working for the company. In 1896, William married Blanche Wilcox. The following year, his father-in-law John W. Wilcox also joined the company. Early stockholders included several members of the Wilcox family. The founder of the company, Charles M. Barnes retired in 1907 and moved to Seattle, Washington. Upon Charles' retirement, his son William became President. In recognition of John Wilcox's contribution to the business, the company name was changed to the C. M. Barnes-Wilcox Company on 20 February 1908. In 1912, C. W. Follett became a shareholder, Director and Vice President of the company. His rise to eventual ownership was well under way.

J. W. Wilcox & Follett Company, 1917-1943

Charles Wolcott Follett was born in Illinois. Anecdotes state that C. W. Follett met his future wife Edythe Benepe in Indiana, and that when she returned to her home in Chicago he followed her there. Charles and Edythe Follett had four sons: Robert D., Garth Benepe, Dwight Wolcott and Charles N. (known as "Laddie".)

In 1901, C. W. Follett was hired by the C. M. Barnes Company to assist in the company's move to new premises. He remained with the company, serving in many capacities over the years. Early in his career with the company, he worked as a salesman in the Oklahoma Territory. In 1912 he became a shareholder, Director and Vice President of the company.

In 1917, then-President of the company William R. Barnes chose to leave the company in order to form a new partnership with his friend Mr. Noble in New York City. This was the origin of the present-day firm, Barnes & Noble. Upon William's resignation, John Wilcox acquired his interest in the company and became its President. Also in that year, three of Charles W. Follett's sons (Dwight, Garth and Robert) were first employed by the company as summer workers.

On 12 March 1918 the company name was officially changed to the J. W. Wilcox & Follett Company. In 1920, the company took a ten year lease on premises at 2008 Calumet Street. By 1927, the company had moved to 1255 S. Wabash Avenue, where it would remain for nearly thirty years.

John W. Wilcox died in 1923. Immediately, C. W. Follett made overtures to acquire a majority holding of the stock. He succeeded in becoming full owner of the company. All four of C. W. Follett's sons joined him in the business; the elder three during the mid-1920s, and the youngest in 1931. After their father's death on 19 December 1952, his sons jointly controlled the company until their own respective retirements.

Under C. W. Follett's management, the company formed contractual agreements with many related businesses, and acquired several others. It also created a number of short-lived subsidiaries, primarily retail book and stationery stores. In 1926, the company organized what was to become a major subsidiary: Follett Publishing Company (FPC.) FPC was created at the instance of Dwight Follett, and was managed by him until his father's death in 1952, when he became President of the company. Dwight's son Robert J. R. Follett then took over the management of FPC.

Wilcox & Follett started its first college book store at the University of Minnesota in Minneapolis. The date of this event is variously reported as 1929, 1930 and 1931. This was the beginning of a specialization in the operation of college book and supply stores which continues today.

Wilcox & Follett Company, 1943-1957

For many years the J. W. Wilcox & Follett Company was informally known simply as "Wilcox & Follett", and even nsed this shortened form of its name on letterhead stationery. On 27 December 1943, the corporate name was officially changed.

In 1955 the company moved to 1000 W. Washington Boulevard, the former home of the National Biscuit Company (known today as Nabisco.) This building was purchased by the Follett family in 1962, and gradually the company's divisions filled the entire building. The corporate offices remained at this location for nearly forty years.

Follett Corporation, 1957 - 2022

In 1957, a major reorganization of the company was undertaken. The new entity was incorporated on 12 December 1957, and began operations on 2 January 1958. As part of this change, Wilcox & Follett Company was dissolved as a separate entity and reconstituted as a division of the new Corporation.

The company continued to form new subsidiaries and to re-combine its operating divisions. Many of these reflect the company's attempts to find new niches in the educational marketplace. In the 1970s, the Corporation explored an entirely different market by purchasing several racquet clubs and other recreational properties. In the 1980s, several large chains of college book and supply stores were acquired.

In 1993, the Corporation moved its headquarters to a building owned by one of its divisions, Follett Campus Resources, at 2211 West Street in River Grove, Illinois.

The Follett family sold the business in 2022.

Scope and Content

This section of the Follett Collection records comprises 8.25 linear feet spanning the years 1873 to 1998 with some undated records. These records include ledgers, applications, bills of sale, financial statements, correspondence, reports, brochures, catalogs, minutes, newsletters, by-laws, and histories.

Arrangement

The collection is arranged into six (6) record groups. Five (5) record groups reflect the growth and name changes of the company. The sixth (6) and last record group covers the subsidiary companies owned by the company.

Each record group is arranged into one or more series – series 1: Administrative, series 2: Financial, series 3: Legal, series 4: Personnel, series 5: Publications, and series 6: Restricted.

Notes

Records sometimes crossover from one company to the next, especially in the early years.

This section of the Follett collection was previously processed by Judith Robbins. It was reprocessed according to Loyola University Chicago Archives & Special Collections standards in 2022.
