## **Administrative History**

The Office of the General Counsel is charged with the responsibility of providing, or causing to be provided, all legal counsel and representation to Loyola University of Chicago and its subsidiaries. It is overseen by the Vice President, General Counsel, and Secretary, a title established in 1989. Previously the position was known as recorder, legal advisor, legal counsel, and secretary. The title of "Recorder" was used from 1925 to 1926 when the office was held by John Coan. From 1932 to 1941 the title of "Legal Advisor" was used with Edward J. Farrell serving in this capacity for the university. In 1967 James M. Forkins was appointed "Legal Counsel", holding the position until 1969 when he was followed by Richard A. Michael who served in the position until 1972. William H. Oswald, J.D., was appointed Secretary of the university in 1974, a position to which was added the titles of Vice President and General Counsel in 1989. Oswald served as Vice President, General Counsel, and Secretary from 1989 until 1995. The current Vice President, General Counsel, and Secretary, Ellen Kane Munro, was appointed in 1995.

# **Scope and Content**

The Office of the General Counsel records consist of 7.25 linear feet spanning the years 1884 to 1989, with the bulk of materials being from 1906 to 1970, and include correspondence; property deeds and title abstracts; articles of incorporation, charters, and by-laws; minutes and resolutions; affiliation agreements; mortgages and loan papers; wills; financial statements; reports; proposals; and court cases. Subjects include Chicago College of Dental Surgery, Rome Center, Board of Managers, Bennett College of Eclectic Medicine and Surgery, Rogers Park property, campuses and buildings,

University Hospital and Medical Center, and the Lake Fill project. Records are alphabetically and then chronologically. Property files are also arranged by address.

## **Series**

#### Series 1: Administrative Papers, 1906-1981, Boxes 1-2
