Biographical Sketch

Kale Williams (1925-) is a devout Quaker, pacifist, human rights activist, U.S. Navy and World War II veteran, and University of Chicago alumni. After his service in WWII, Williams began a career with the American Friends Service Committee and in 1968 led an international team of Quakers to both Nigeria and Biafra during the countries' civil war to provide food and medical services. In 1966, Williams worked closely with Martin Luther King Jr. through his involvement in the Chicago Freedom Movement. In 1972, Williams became the executive director of the Leadership Council for Metropolitan Open Communities. In 1994, Kale Williams joined Loyola University Chicago as the first holder of the Considine Chair in Applied Ethics. The position was intended to bridge Loyola and the community, specifically the Rogers Park neighborhood. While at Loyola, Williams taught courses on Chicago Civil Rights history, racial segregation, urban studies, and world hunger. Following his visiting professorship, Williams served as the Senior Scholar in Residence at the Center for Urban Research and Learning (CURL, established in 1996) for ten years. The Kale Williams Award for Exceptional Work in Promoting Human Rights and Social Justice award was established by CURL and is given to two CURL undergraduate or graduate fellows who exemplify the work and ideals of Kale Williams.

Scope and Content

The Kale Williams Papers consist of 7.5 linear feet spanning the years 1962-2006. This collection includes correspondence, articles, drafts, summaries, notes, and research materials relating to Williams's involvement at Loyola University Chicago and the Center for Urban Research and Learning (CURL), as well as projects on which he consulted.

Series

Series 1: Loyola University Chicago, 1962-2006, Undated. Boxes 1-2

This series contains articles, correspondence, course readings, and reports. Notable topics include Civil Rights, the Chicago Freedom Movement, racial segregation, the Chicago Foundation for Women, Fulfilling the Dream, non-violence, urban studies, and world hunger.
