Biographical Sketch

Richard A. McCormick, S.J., was born October 3, 1922, in Toledo, Ohio, one of six children born to Edward J. McCormick, a physician and a president of the American Medical Association, and Josephine Beck McCormick. He attended Toledo Cathedral Elementary School and then Campion High School, a boarding school in Prairie du Chien, Wisconsin. On August 31, 1940, following graduation from high school, he entered the Society of Jesus and began his studies at the Jesuit seminary in West Baden, Indiana. McCormick received a bachelor's of arts degree from Loyola University Chicago in 1945 and in 1947 he was assigned to teach English and Greek at St. Ignatius High School in Cleveland, Ohio. He taught there for three years before returning back to Loyola University Chicago where he received a master's degree in English in 1950.

Ordained to the priesthood on June 17, 1953, McCormick attended the Pontifical Gregorian University in Rome from 1955 to 1957, where he received a doctorate in moral theology. From 1957 to 1973 McCormick taught moral theology, first at West Baden College and then in Chicago at Loyola University Chicago's Bellarmine School of Theology. In 1974, he was named the Rose F. Kennedy Professor of Christian Ethics at the Kennedy Institute of Ethics at Georgetown University, where he stayed until 1986. In 1987 he was named as the John A. O'Brien Professor of Christian Ethics at the University of Notre Dame, where he stayed for the remainder of his career.

He was a noted author and expert in the areas of Roman Catholic moral theology and medical and bio-ethics. His numerous writings gained him an international reputation. One of his most notable works was "Notes on Moral Theology", which was published annually from 1965 to 1984 in *Theological Studies*. In addition, he was the author and editor of numerous scholarly works including *The Critical Calling: Moral Dilemmas since Vatican II* and was often featured in mainstream publications such as the *New York Times*.

McCormick was a traditionalist who held a moderate viewpoint on various issues. His theological views changed throughout his career, and he often challenged the Church's position on issues such as sexual and marital ethics although he was still considered a conservative on issues such as abortion and euthanasia. McCormick was a proponent of the concept of proportionalism, which dealt with the question of absolute norms in moral theology.

Throughout his professional and academic career, Father McCormick was the recipient of numerous awards and honors, and served on a variety of boards and committees. In 1969 he received the Cardinal Spellman Award as "Outstanding Theologian of the Year." In addition, he received many honorary degrees from universities such as Georgetown, Fordham, Loyola University Chicago, and the Catholic University of Louvain, Belgium, in recognition of his work. McCormick was a past president of the Catholic Theological Society of America; a member of the Ethics Advisory Board of the Department of Health, Education and Welfare; and served on ethics committees for the American Fertility Society, the American Hospital Association, and the National Hospice Organization.

In June 1999 Richard A. McCormick, S.J., suffered a stroke from which he never fully recovered. He passed away on February 12, 2000, at the Jesuit Community, Columbiere, in Clarkston, Michigan.

Scope and Content

The Richard A. McCormick, S.J., Papers consist of 50 linear feet spanning the years 1940-2000, with the bulk dating from 1965 to 1999, and includes biographical materials; manuscripts and unpublished papers; correspondence; notes; course syllabi; lectures; sermons and homilies; photographs; published articles; newspaper and journal clippings; conference and committee meeting packets and proceedings; pamphlets and brochures; theses and dissertations; diplomas, certificates, and plaques; and VHS and audio cassettes. Subjects covered include biomedical ethics, moral theology, and the Catholic Church.

<u>Series 1: Biographical, 1940 – 1999, Box 1</u>

Includes diplomas, photos, and correspondence relating to McCormick's childhood, family, education, and leisure activities.

Series 2: Jesuit Activities, 1940 – 2000, Boxes 2-3

Consists of sermons, homilies, notes, manuals and handbooks relating to McCormick's work as a Jesuit.

Series 3: Teaching, 1943 – 1999, Boxes 3-11

Consists of student theses and dissertations, proposals, lecture notes and papers, and course syllabi relating to McCormick's work as an educator.

Series 4: Professional Life, 1965 – 1999, Boxes 11- 12

Includes newspaper article clippings, faculty contracts, certificates, correspondence, and photos relating to McCormick's professional activities outside of teaching, for example his endowed chair position at the Kennedy Institute.

Series 5: Lectures, 1966 – 1999, Boxes 12-16

Includes pamphlets, fliers, and announcements of speaking engagements; lectures and notes; and correspondence relating to lectures given by McCormick. Subjects include biomedical ethics and moral theology.

Series 6: Manuscripts and Unpublished papers, 1966 – 1999, Boxes 17-29

Includes drafts, final published versions of articles, and correspondence relating unpublished manuscripts and papers by McCormick, as well as other authors. Subjects covered include moral theology and biomedical ethics.

Series 7: Published Writings, 1962 – 1966, Boxes 30-37

Includes correspondence, book reviews, publishing contracts, and notices about book publication celebration for writings by McCormick, S.J., as well as other authors. Subjects covered include biomedical ethics and moral theology.

Series 8: Honors, 1969 – 1997, Boxes 38-45

Honorary degrees and certificates of recognized service awarded to McCormick. Materials include newspaper article clippings, certificates, correspondence, diplomas, photos, and plaques. Boxes 40 - 45 are oversized.

Series 9: Biomedical Ethics, 1954 – 1999, Boxes 46-55

Includes newspaper and magazine clippings, reports, handbooks, directories, notes, and correspondence relating to topics in biomedical ethics. Subjects include reproductive technologies and infertility, death and dying, defective newborns and fetal experimentation, birth control and *Human Vitae*, Catholic hospitals and health care, genetics, and AIDS.

Series 10: Medical Ethics Conferences, 1966 – 1999, Boxes 55-67

Includes conference packets, reports, notes, and correspondence from medical ethics conferences and committees. Conferences covered include those sponsored by the University of Notre Dame, the American Fertility Society, the AHA, the Park Ridge Center, and the Center for the Clinical Medical Ethics.

Series 11: Moral Theology, 1950 – 1999, Boxes 67-72

Includes newspaper and magazine clippings, notes, and correspondence relating to topics in moral theology, general ethics, and the Catholic Church. Subjects include moral theological concepts; dissent; the Catholic Church; *Vertatis Splendor*; and marriage, divorce, and sexuality.

Series 12: Periodicals, 1952 – 1999, Boxes 72-84

Includes journals and magazines saved by McCormick. Some issues contain articles written by him. Subjects include biomedical ethics and moral theology.

Series 13: Audio-Visual, 1977 – 1999, Boxes 85-90

Includes VHS video cassette tapes and audio cassette tapes, including recorded talks by McCormick. Topics include biomedical ethics, Catholic ethics, and moral theology.
