Administrative History

Peoples Gas Light & Coke Company was organized in 1848, becoming Chicago's first gas company in 1850. Under the presidency of C.K.G. Billings, Jr. (1895 to 1910), Peoples merged with twelve other companies to become a major power in public utilities in the Chicago area. In 1980 the company changed its name to Peoples Energy Corporation and continues to serve the Chicago area.

Scope and Content

The records in this collection relate to Samuel Insull's affiliation with Peoples Gas Light & Coke Company, specifically his tenure as chairman of the board (1913) and as president (1919-1932). In addition, records pertaining to several other Insull companies are included. The records comprise 2.25 linear feet spanning the years 1887 to 1952, with the bulk of the records being from 1909 to 1930, and consist of correspondence; speeches; reports; resolutions; agreements; minutes; newspaper clippings; stock certificates, and publications. Arrangement is alphabetical-chronological.

<u>Series</u>

Series 1: Samuel Insull, 1913-1937, Box 1

This series consists of correspondence, reports, resolutions, copies of checks, statements, speeches, publications, and one photograph. Subjects include People's Gas Light and Coke Company; universal military training; War Industries Board; income tax; women employees; Insull's pension; and labor relations.

Series 2: Peoples Gas Light and Coke Company, 1905, 1909-1934, 1950, Boxes 2-3

This series consists of correspondence, reports, memorandum, statistical data, histories, and publications. Subjects include Peoples Gas Light and Coke Co. history; Chicago river and harbor improvements; gas lights; gas rates ordinances; product inquiries; service requests; and profit sharing plans.

Series 3: Indiana Natural Gas and Oil Company, 1889-1938, Boxes 3

This series consists of correspondence, legal papers, and stock certificates. Subjects include Indiana Natural Gas and Oil Company; Peoples Gas Light and Coke Co.; and Samuel Insull.

Series 4: Insull Companies in Indiana, 1926, Box 4

This series consists of one scrapbook containing articles about the Northern Indiana Public Service Co.; Indianapolis Light & Heat Company; and Central Indiana Power Company in addition to other Insull companies in Indiana.

Series 5: Greentown Natural Gas, Oil, Mining and Pipeline Company, 1887-1938, Box 4

This series consists of legal agreements, articles of incorporation, correspondence, and minute book.

Series 6: Other Companies, ca. 1880-1900, 1926, Box 4

This series consists of contracts and stock certificates for several companies.

Series 7: Publications, 1920-1934, 1952, n.d., Boxes 4-5

This series consists of articles, addresses, and booklets, by people other than Samuel Insull and pertaining to public utilities and the gas industry.

This series contains a pin from the American Gas Association.
