Administrative History

The Office of Registration ad Records was established as the Office of the Registrar in 1921. The first Registrar of the College of Arts and Sciences was George P. Shanley, S.J., who also served as Dean of the College. This office was established to document, record, and oversee all undergraduate student educational records. During the mid-1920s the professional schools – Law, Medicine, and Dentistry – established their own separate Registrars.

Scope and Content

The Registrar's records consists of 1.5 linear foot spanning the years 1922-1965 (bulk 1930s & 1940s). Bertram J. Steggert served as Registrar between the years 1922 and 1947, followed by Lymann J. Templin, 1947-1948, and Elizabeth A. McCann, as Acting Registrar in 1949, then as Registrar in 1950. The records are arranged alphabetically and chronologically.
