Administrative History

Before Loyola had an office dealing with veteran related issues and veteran benefits, the Committee on Veterans Education was formed toward the end of World War II in anticipation of problems with reintegrating veterans into higher education. In the 1946-1947 academic year, Loyola had approximately 3,600 veterans attending the university. A dedicated veterans affairs office was founded in 1946 by Eugene Knight, a graduate of DePaul University and veteran of the U.S. Army Air Corps, to assist the influx of World War II veterans.

The office was responsible for keeping financial records of student veterans at the university utilizing veteran benefits, implementing government policy and programs for veterans, as well as advising veterans on navigating these benefits and programs. The primary benefit used by veterans during periods of war was the G.I. Bill. The G.I. Bill has gone through multiple iterations, with the original G.I. Bill of 1944, the Korean War G.I. Bill, the Vietnam War G.I. Bill, and the Montgomery G.I. Bill. The G.I. Bill provided veterans with financial aid toward tuition and other university expenditures, such as schoolbooks, pencils, notebooks, and other university related necessities. Veterans utilized the Veterans Affairs office to register for the G.I. Bill and submit their bookstore receipts to show the necessary school items they purchased. The office was

responsible for submitting this information to the government in order to receive the necessary financial aid. The office kept track of student veteran GPAs to assure veterans were maintaining a good academic standing, as this was also a requirement to receive G.I. Bill benefits, and distributed government publications, such as pamphlets and folders containing information on the education benefits that veterans could receive.

Scope and Content

The Office of Veterans Affairs records consist of 8.0 linear feet spanning the years 1947-1985. The collection includes administrative procedures, government programs and scholarship information for students and student veterans, pamphlets, catalogues, and informational handouts from the U.S. Government, enrollment and admissions records, student invoices and bookstore receipts, grade reports, veteran rosters, and correspondence. Series are arranged chronologically.

Series

Series 1: Administrative, 1953-1980, Undated

This series contains admissions and enrollment statistics and procedures, GI Bill statistics, regulations, and laws, student veteran certification laws, VA Education Loans, student veteran major statistics.

Series 2: Correspondence, 1954-1978

This series contains correspondence between Loyola's Office of Veterans Affairs, State Approval Agency correspondence, National Defense Student Loan Program correspondence, admission procedure correspondence, and other correspondence regarding veterans' policies and procedures.

Series 3: Work Study, 1964

This series contains information regarding procedures of the Work Study program.

Series 4: National Defense Education Act & National Defense Student Loan Program, 1959-1967, Undated

This series contains information related to the National Defense Education Act, National Defense Student Loan Program, cumulative reports, records, procedures, and instructions.

Series 5: Government Publications, 1947-1980, Undated

This series contains U.S. Government publications related to the National Defense Education Act, veterans, higher education financial aid, higher education salaries, the GI Bill, studies and data on Vietnam veterans, and veterans training.

Series 6: Restricted 1960-1985, Undated

This series contains information related to grades, rosters, scholarship awardees, student refunds, student invoices, bookstore receipts, and other student information.
