Referrals from Northside Learning Center allow 711 law students enrolled in the Community Law Center to represent families, draft requisite pleadings, and appear at hearings in the Probate Division.

Created an instruction manual for Cook County families in need of guardianship of disabled adult child upon their 18th birthdays that guides pro se litigants through the statutory requirements, legal pleadings, filing provisions, court room procedure, and more.
