Loyola's CCJ to assist Governor's Commission in Implementation of Recommendations on Criminal Justice Reform

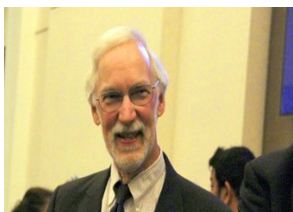
The Illinois Governor's Commission on Criminal Justice and Sentencing Reform released its final report and set of recommendations on Tuesday, January 10, 2017.

Dr. David Olson, Professor in the Department of Criminal Justice and Criminology and Co-Director of Loyola's Center for Criminal Justice Research, Policy and Practice served as an appointed member of the Commission. Loyola's Center for Criminal Justice Research, Policy and Practice has received support from the John D. and Catherine T. MacArthur Foundation to conduct research and provide technical assistance to implement a number of the reform efforts described in the Commission's Final Report, and over the next two years faculty and students from a variety of academic disciplines at Loyola will be working on these efforts.

Cardinal Bernadin Common Cause Lecture: Called to Witness

The Hank Center for the Catholic Intellectual Heritage, in collaboration with the Loyola University Jesuit Community, sponsors its inaugural Cardinal Bernadin Common Cause lecture this April 18. The lecture offers a Catholic prelate each year a platform to engage Loyola's community in common cause with the Church on issues facing us today.

The Common Cause Lecture is named after Joseph Bernadin, Cardinal Archbishop of Chicago from 1982 to 1996, for his influential work toward Church reform after the Second Vatican Council through his Catholic Common Ground Initiative. Bernadin further sought to address social issues, especially in developing his "Seamless Garment Ethic of Life." He also worked toward ecumenism and interfaith dialogue throughout his life.

In honor of Cardinal Bernadin's legacy, Cardinal Blase Joseph Cupich, Archbishop of Chicago, will address our common ground in a time of division. Cardinal Cupich is the current Archbishop of Chicago, installed in 2014, after previously serving as Bishop of Rapid City and Spokane. He received his doctorate in Sacred Theology at the Catholic University of America. Pope Francis elevated Cupich to Cardinal this past fall. He has upheld Cardinal Bernadin's call for a "consistent ethic of life" for all people.

Center for the Human Rights of Children (CHRC)

CHRC Response to Recent Executive Order Affecting Refugees and Immigrants

February 1, 2017. As an interdisciplinary children's rights center with a mission to promote and advance the rights of children, Loyola University Chicago's CHRC denounces the Executive Orders affecting immigrants and refugees signed by President Trump. Among other provisions, these orders suspend entry of Syrian refugees and immigrants from six predominately Muslim countries, limit entry of refugees to historic lows, and expand immigration enforcement and detention within the United States.

These executive actions flout our nation's historical protection of immigrant and refugee families and ignore that the failure to extend this protection has resulted in some of the darkest moments in our history. We share the sentiments of Nobel Peace laureate and activist Malala Yousafzai who said these orders' effect is to "turn your back on the world's most defenseless children and families."

The number of children around the world who can no longer live safely and freely in their country of origin has reached a historic high. According to the United Nations High Commissioner for Refugees (UNHCR), there are 65.3 million displaced persons globally, half of whom are children. The Department of State reports that a majority (60 percent) of the Syrian refugees admitted to the United States are under the age of 20, and nearly half are under the age of 14. Many of the children who will be most affected by these executive orders, such as those fleeing Syria, are the victims of war and trauma. Similarly, many Central American children who seek refuge in the United States have experienced unprecedented levels of violence. For immigrant children who are already in the U.S., many of whom are members of families who have contributed to our communities and economy for years, the impact of increased enforcement measures will only exacerbate fear, trauma, and mistrust, impeding their healthy development.

The Center for the Human Rights of Children upholds its commitment to defend universally recognized laws and principles, such as the United Nations' Convention on the Rights of the Child, and to protect the most vulnerable members of our society.

2017 Coffey Award

Joyce Saxon (MUND '49) is a pioneer for women, one whose professional career shattered the glass ceiling at the executive level in the advertising industry, demonstrating the power of a Mundelein College education and the determination of its graduates.

Saxon served as the first female senior vice president at J. Walter Thompson (JWT), one of the largest and oldest advertising agencies in the U.S. In her 25-year tenure with JWT, her responsibilities included positions as spot broadcast manager and syndication manager. Extremely accomplished in both roles, she placed \$51 million each year in broadcast advertising and identified TV networks throughout the U.S. for syndicated news programs, one of which won the coveted Peabody Award for Excellence in Journalism.

Saxon also worked in the culinary arts industry as the personnel director for Culinary Enterprises and is a co-founder of Chicago Gourmets, a culinary organization of over 300 members that seeks to educate and provide diverse culinary experiences to the community.

As an active member in the Chicago community, Saxon serves on the City Club of Chicago Board of Governors and was the executive director of the Old Town Chamber of Commerce and manager of the Wells Street Art Fair. Her involvement with TV, radio, and cable continues as treasurer-for-life of the Broadcast Advertising Club of Chicago.

At Loyola, Saxon has been very involved for many years with the Loyola University Museum of Art (LUMA) as a docent, member, and major contributor. Beyond Loyola, she has served as a Chicago Art Institute Sustaining Fellow and a Newberry Library President's Fellow. She is also a member of the Dead Writers Board of Directors. Saxon was raised in Chicago's Old Town neighborhood and graduated from Mundelein College in 1949.

NSF Releases New Grant Application Guide

The National Science Foundation (NSF) has announced that a revised version of the [NSF Grants.gov Application Guide](#) has been issued. The *NSF Grants.gov Application Guide* has been updated to align with changes to NSF's the [Proposal & Award Policies & Procedures Guide \(PAPPG\) \(NSF 17-1\)](#). All references to the *Grant Proposal Guide (GPG)* and *Award & Administration Guide (AAG)* have been replaced with references to the PAPPG. Each set of terms and conditions is accompanied by a summary of changes made to that document. Editorial changes have also been made to either clarify or enhance the intended meaning of a sentence or section or to ensure consistency with data contained in NSF systems or other NSF policy documents. Further, the Foundation's entire suite of [Award Terms and Conditions](#) (see full listing below) has been revised to align with changes to the [Proposal & Award Policies & Procedures Guide \(PAPPG\) \(NSF 17-1\)](#).

The new [NSF Grants.gov Application Guide](#) and revised instructions will be effective for **proposals submitted, or due, on or after January 30, 2017 and to funding amendments submitted after that date.**
