ORS is happy to announce the following changes to our staff.

**Angelica Vaca** has been named Director of Research Services, effective immediately. Angie was appointed Interim Director of Research Services in 2015. She is a Certified Research Administrator and has worked in research administration at Loyola University Chicago since 1999. Angie has been instrumental in designing the content for our in-house proposal submission and management system known as PTAP. She has helped streamline policies and procedures to enhance research administration. Angie will supervise all ORS operations.

**Andrew Ellis** has been named Associate Director of Research Compliance, effective immediately. Andy joined Loyola University Chicago in 2009, serving as Assistant Director for Research Compliance. continue to oversee all research compliance activities, serve as Chairman of the Radiation Safety and Institutional Biosafety Committees and coordinate intellectual property.

**Projects By PI:** Projects that you are the Primary Investigator  
**Projects By Sponsor:** Projects that you are indicated as Sponsor  
**Projects By Proxy:** Authorized projects by PI to allow you to work on them on his/her behalf.  
**IRB Applications:** IRB applications that you are indicated in the section **1. Personnel** as Loyola faculty, staff, or student.

The Compliance Approval Portal (CAP) system has a new feature allowing you to “hide” projects that you don’t need anymore. Simply select the “hide” box for your old/closed projects and they will disappear from your list, leaving you with a list of your current projects. If you accidentally hide something you need later on, use the “show hidden projects” box to see your hidden projects or deselect the hide box so that they return to your main page list.

### CITI Program Changes – COMING SOON

This year Loyola Researchers will see two big changes to the online CITI training program. First, by the end of 2018 there will no longer be a need to remember a second user name and password for your CITI Program account! The CITI Program log in process will be changing as the Loyola University Chicago ITS system begins to link with the CITI program site allowing Loyola users to sign into their CITI Program accounts with their LUC username and passwords.

In addition, Loyola users will gain access to new content called "Information Privacy & Security (IPS)". IPS covers the principles of data protection, including the healthcare-related privacy and information security requirements of the Health Insurance Portability and Accountability Act (HIPAA) and the educational records and data-related requirements of the Family Educational Rights and Privacy Act (FERPA).

## PTAP Tips

### Proposal Transmittal Approval Process (PTAP)

The PTAP is our user-friendly on-line routing and approval system for all extramural funding proposals. Faculty are required to create a PTAP record as the first step in the submission process. The system prompts you to enter information on applicable federal compliance requirements, project budgets, Co-PIs, etc., and to attach your narrative. After the grant is awarded, the PTAP provides a repository for documented grant management activities (e.g. compliance renewals, budget adjustments).

- Budget -- Excel
- Budget justification -- PDF or WORD
- Copy of the Proposal -- PDF

Research Administrators in ORS will be happy to assist you with the process.

ORS offers three internal grants to support full-time faculty in their research: Manuscript Publication Assistance, Book Subvention, and Research Support Grants. 
### HHS Announces New Conscience and Religious Freedom Division

The U.S. Department of Health and Human Services (HHS) has announced the formation of a **new Conscience and Religious Freedom Division in the HHS Office for Civil Rights (OCR)**. OCR is the HHS agency that enforces federal laws protecting civil rights and conscience in health and human services and the privacy of people's health information. The new division will enable HHS to more effectively enforce laws protecting the fundamental and unalienable rights of conscience and religious freedom.
