This Student Performance Agreement (this "Agreement") is to be read and signed by students of Loyola University of Chicago ("Loyola") who are performing at the event(s) above (the "Event"). In return for Loyola allowing me to perform at the Event, and other good and valuable consideration, I agree, and state, on behalf of myself, my heirs, assigns, executors and all others, as follows:

1. I understand that Loyola is not legally responsible for my personal safety or the safety of my property at the Event. I will ensure that the content of my performance at the Event is in accordance with the Catholic, Jesuit identity of Loyola and is "radio-friendly" and is not obscene, indecent and profane.
2. I am familiar with and will obey all Loyola rules and policies for the Event, including Loyola's Community Standards and Code of Student Conduct. I will obey all applicable laws, including those that relate to alcohol or consciousness-altering drugs. I will not use or be under the influence of alcohol or consciousness-altering drugs, whether obtained or taken legally or not, while performing at the Event. I understand that performing at the Event while under the influence of such substances could endanger myself and/or others.
3. I understand and appreciate the inherent risks and dangers of performing at the Event, which could result in property damage and/or personal injury, and I agree to accept and assume all risks, whether present or future, known or unknown, resulting from or arising out of my performance at the Event. I assume responsibility for all costs, fees and expenses incurred by me at the Event. I acknowledge that Loyola does not provide personal accident/health insurance to me in my capacity as a performer at the Event. I represent that I have adequate health and hospitalization insurance for any injuries that I may receive as a result of my performance at the Event. I recognize that Loyola is not obligated to attend to, and I assume all risk and responsibility for, my medical and medication needs.
4. I waive, release and discharge and agree to hold harmless and indemnify Loyola, its affiliates and subsidiaries and their respective trustees, officers, directors, representatives, administrators, officials, employees, agents, students, volunteers, successors, assigns and any other individuals assisting or involved in the Event (collectively, "Releasees") from any and all liability, actions, causes of action, suits, claims, damages, costs, fees and expenses whatsoever for any injury, loss, damage, accident or inconvenience or expense, present or future, known or unknown, anticipated or unanticipated, resulting from or arising out of the Event or my performance at the Event.
5. I authorize Releasees to record my performance at the Event on video tape, audio tape, film, photograph or any other medium and to use such recordings and my name in all mediums and all means of communication now and in the future. I waive and release Releasees from any claim, action, suit, or damage whatsoever by reason of anything contained in the recording or in connection with or arising out of the use, reuse, duplication, distribution, broadcast, publication, republication and marketing of any recording. I understand and acknowledge that this Agreement will be governed by and construed in accordance with the laws of the State of Illinois.
6. I will provide Loyola's staff representative responsible for the Event, with at least two weeks prior written notice before the Event if I need to cancel my performance at the Event.
7. I will at all times, and at my own expense, be responsible for all applicable returns, reports, taxes and assessments arising out of the Event.
8. I have read and understand this Agreement, I agree to be bound by this Agreement and I affirm that I am performance at the Event voluntarily of my own free will. I am either: (a) 18 years of age or older; or (b) under 18 years of age and my parent or legal guardian has signed this Agreement below.
