How quickly can I finish my degree?

You can finish your B.A. degree at Loyola in two years.

What can I major in?

Students in the SCPS have eight majors to choose from: Applied Criminal Justice Leadership, Applied Communication Applied Psychology, Applied Studies, Information Technology, Leadership, Management, Paralegal Studies and Social Work.

How much credit can I transfer?

Loyola can accept 64 credits from CLC, including half of the major requirements. Transfer Students must complete a minimum of 45 credits at Loyola.

Will I have any Core left?

Students completing an A.A.S. in Paralegal Studies will have 27 credit hours remaining to complete Core requirements: COMM 101 or 103, UCWR 110, a Quantitative Literacy course, 2 Scientific Literacy courses, a Societal course, 2 Humanities courses, and a Fine Arts course.

MTH Elective Suggestion for 4th Semester: MATH 144 or 222. Completing one of these two courses will satisfy your Quantitative requirement.

After Core, what other requirements do I need?

- *Mission Specific Courses*: six credit hours of coursework in the fields of philosophy and/or theology.
- *SCPS Courses*: three courses focused on personal and professional identity and development (9 credit hours). (See next page)
- *Major Courses*: Students can transfer up to half of the major credits.

In total, students must complete 120 hours to earn a degree at Loyola.

Can I earn credit in other ways?

Students can earn credit for experience-based learning for up to four courses in the major and up to 36 credits total. Pursuing non-traditional sources of credit offer opportunities to earn credit for knowledge gained through life experiences that qualify as college-level learning, providing substantial savings of time and tuition.

Where are classes held?

- Online—perfect for working adults balancing work, life, and school.
- Downtown Water Tower Campus (820 N. Michigan Ave.).

When are classes held?

SCPS offers evening, weekend, and online classes during the eight week sessions we offer throughout the year.
