Biographical History

Jean Galbraith Brown was born on April 13, 1918, to parents Arthur Galbraith Brown and Agnes Scott Kinloch in Evanston, Illinois. In 1930, she moved to the Edgewater neighborhood of Chicago and attended Sullivan Junior High School and Senn High School. In 1938, Jean married Marvin Fritz, and the two moved to Des Plaines, Illinois in 1940 where they raised their three daughters. She was a stay-at-home mother and worked with her husband at his auto shop franchise as their children got older.

Jean Fritz was one of the jurors of the Chicago Seven conspiracy trial in 1969-1970. The trial investigated seven defendants with charges from the federal government related to their involvement in antiwar protests surrounding the 1968 Democratic National Convention in Chicago. The trial is also referred to as the Chicago Eight because the case against defendant Bobby Seale was declared a mistrial when he was bound and gagged to his chair after requesting to represent himself, leaving seven defendants in the conspiracy trial.

On February 18, 1970, the jury found the defendants not guilty on all conspiracy charges and found five of the seven defendants guilty of traveling across state lines with intent to incite a riot. The trial was a microcosm of the larger cultural clashes of the 1960s in the United States, where

the seven defendants represented the antiwar counterculture going up against the status quo of the state. It remains one of the most publicized trials in United States history.

Following the trial, Jean Fritz was often in communication with journalists, documentarians, and authors, sharing her experiences as a juror. Fritz died at the age of 99 on January 23, 2018.

Scope and Content

The Jean Fritz papers consist of 8.25 linear feet of material and span the years 1927-2020. The materials consist of photographs, slides, scrapbooks, newspapers, publications, exhibit materials, books, correspondence, and journals. Strengths of the collection include Jean Fritz's handwritten journals she kept during the trial and exhibit material from a 2019 exhibition about Fritz at the Edgewater Historical Society.
